CWaC Local Plan- potential removal of land from the Green Belt

As many residents will have seen, CWaC is in the process of updating the Local Plan which will set out where development will take place in Cheshire West and Chester.

Three options are being considered:

Option A is to retain the Green Belt and the other two options would see withdrawal of Green Belt in a number of areas including land to the east side of the village, backing on to the A41.

The Parish council has sent a comprehensive and detailed response as part of the consultation, stating that Option A and retaining the Green Belt is the preferred option.

In addition, Guilden Sutton Parish Council is part of the Green Belt Alliance. This is a newly formed coalition which also includes, Christleton, Littleton, Waverton, Mickle Trafford and Great Boughton Parish councils. A planning consultant has been appointed and fully briefed to represent the local villages and again, to emphasise that Option A is the preferred option. Whilst

the Parish Councils do not make the decisions, Guilden Sutton PC, along with all our local PCs is committed to representing resident views and protecting the Green belt from inappropriate development.

Don't let your hedge be a hazard

CWaC's latest campaign seeks to outline the dangers that can be caused by hedges and trees overhanging the public highway. In almost all cases, hedges are actually owned by the adjacent landowner/ resident and not the Council. Overgrown vegetation can pose a real hazard to the safety of pedestrians as well as the potential to increase the risk of accidents for drivers. It is an offence under the Highways Act 1980 to allow trees, hedges or shrubs to obstruct the highway. If there is an issue the Council will serve an initial informal request, followed by a 14 day notice to cut back the offending vegetation. After this, if the vegetation is still not cut back, the Council may arrange for the work to be done and will recover the costs from the landowner. All residents are asked to check their boundaries and to make sure hedges and trees aren't obstructing the footpaths or public highway.
